SI. No.	The school is directed to ensure that :
1	The total number of sections of Balvatika shall be restricted to 3 (One each in Balvatika 1,2 and 3). It is mandatory to run Balvatika from the Academic Session 2024-25 as per Circular no. 12 dated 24.03.2023. The total number of sections from classes 1 to 12 shall be restricted to 26, out of which not more than 1/3rd sections may be used for senior secondary classes. For class rooms of size less than 500 sq feet the enrolment shall be 0.08 X size of class rooms in sq feet. and in other rooms above 500 sq. ft., the optimum number of the students shall be restricted to 40 in each section. Any further increase of section shall require prior approval of the Board, subject to compliance with affiliation bye laws and availability of rooms of 500 sq. ft. dimension.
2	Some part of the boundary wall is topped with iron railings. The boundary wall should be fully concrete without any gaps/grills/iron mesh/ and of 6 ft height all around the school building. The school should construct proper boundary wall on all sides and submit the compliance through videography on SARAS portal.
3	There are only 35 computers in the computer lab. The school does not have the minimum number of computer i.e. 40. The school should procure more computer to maintain 1:18 computer to student's ratio or minimum 40 computers as per Circular no. 10 dated 24.03.2023 and submit the compliance through videography within 3 months on SARAS portal.
4	The school should install the safety features such as fire extinguisher and exhaust fan in the Biology lab and submit the compliance with videography within 3 months on SARAS portal.
5	Proper work station with electrical connections and fire extinguisher should be installed in Physics lab and submit the compliance through videography within 3 months on SARAS portal.

- The school has converted regular cubicles into CWSN toilets, but they are very narrow and there is no room for a wheelchair/walker to navigate. Thus, the school is required to construct the CwSN toilets separately for boys and girls on each floor with sufficient space for easy movement of the wheelchair as well as handrail on both side of toilet seat (fixed and movable) and proper permanent signage (on the cubicle indicating the floor number) as per norms of RPwD Act and board's guidelines within 03 months and submit the compliance with videography on SARAS portal.
- 8 The school should ensure training of teachers with CoE Dehradun and submit compliance within 3 months on SARAS portal.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

- The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
- The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- 4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- 5. The school shall renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
